THE VIZCAYANS RECEIVE \$500,000 GRANT FOR RESTORATION OF VIZCAYA'S SUTRI FOUNTAIN GARDEN FROM THE TIFFANY & CO. FOUNDATION

Miami, FL – (October 2, 2008) – The Vizcayans is pleased to announce that The Tiffany & Co. Foundation recently awarded a \$500,000 grant for the restoration of the Sutri Fountain Garden at Vizcaya. This grant, along with ones to Grant Park in Chicago and Hermann Park in Houston, furthers The Tiffany & Co. Foundation's mission to preserve the natural heritage that distinguishes great urban centers. This grant provides an essential private sector match for an award from the federal government's Save America's Treasures program and becomes an important part of a comprehensive restoration plan for Vizcaya's buildings, gardens and outdoor statuary. The core funding for Vizcaya's comprehensive restoration plan is a \$50 million allocation of bond funds from Miami-Dade County approved by voters in November 2004.

"Vizcaya Museum and Gardens is a national treasure," said Fernanda Kellogg, president of The Tiffany & Co. Foundation. "Restoring the Sutri Fountain Garden maintains the natural splendor of this historic preserve and also pays tribute to The Vizcayans, our partnering organization, and those who first envisioned the gardens as a glorious setting of beauty and repose.

On October 2, 2008, the National Trust for Historic Preservation awarded The Vizcayans its President's Award saluting the organization's half-century of preservation work at Vizcaya. The President's award is special recognition by the President of the National Trust for Historic Preservation for outstanding and exemplary achievements in historic preservation. On February 24, 2009, The Vizcayans will host the first annual "Vizcayans Conservancy Luncheon", modeled after the fabulously successful Central Park Conservancy Luncheon which raises millions of dollars to support New York's Central Park. The Vizcayans Conservancy Luncheon will be held on the Mound at Vizcaya.

Vizcaya is one of the most complete remaining examples of classical architectural and landscape design from the American Renaissance inspired by the traditions of the European Renaissance. Today, the 50-acre estate includes a main house, featuring 34 decorated rooms; 10 acres of formal gardens; and a native hardwood hammock and mangroves. Accredited by the American Association of Museums, offers tours in multiple languages and is open to the public 364 days per year.
